PSYCHOANALYTIC FORMULATION

Dr. Art Caspary

Diagnosis is an unfortunate word, imported as it is from medicine and having the connotation of identifying a disease process based on signs and symptoms. Like the word psychoanalysis itself, it is rooted in history and distorts its actual meaning in psychoanalytic practice.

Diagnosis is a subset of character and, as such is best described meta-theoretically by nonlinear dynamic systems theory as a set of interacting variables that can usefully be thought of as information or, more generally stimuli, that co-vary interdependently. This information arises endogenously and exogenously via perception and somatic sensations that may or may not have the characteristics of drives. What is important is that all aspects, be it the "raw" data of perception or complex subsystems such as self-states are in constant flux as they are moderated by the systemic matrix that they are a part of. Some theories privilege endogenous stimuli, some privilege exogenous stimuli, especially the relational matrix but as far as I know, all theories maintain that these variables exist in a dialectical relationship to one another. Even though open systems are constantly in flux as they adapt to changing internal and external environments, they nonetheless tend toward overall stability through the use of homeostatic processes. Examples of homeostatic processes would include identity, defensive/adaptive strategies and the representational world. As we all know, any particular configuration is a product of identifications, adaptive and non-adaptive solutions to developmental crises and the "freezing" of certain sectors of the psyche that is the sequela of trauma, relational or otherwise.

We also know that interpersonal strategies are an important aspect of homeostatic function and their adaptiveness in terms of generating vitality, intimacy and growth are a product of the above factors. We need others to maintain identity and, to the extent we are compromised by developmental trauma we both find and create relationships that can be binding or freeing, but always help to maintain a degree of stability for the system of our psyche.

Obviously, some ways of being organized are more practical in terms of offering adaptive flexibility and satisfaction. Those that are more rigidly maladaptive we have traditionally called character neuroses. (Here again, our language is rooted in the past and needs updating.)

Nonetheless, it these ways of being organized that we, as psychoanalysts tend to try to help by implementing processes that allow for greater open-system functioning; lives lived creatively, rather than endured by the pursuit of illusory safety.

Psychoanalytic diagnosis is about using the experience of others and the findings of research to better understand and help people who are trapped in problematic intra-psychic and relational systems. It should be a given that we do not simply fit our patients into pre-formed categories but rather, like all clinical theory, use these descriptors as guides to empathy and hypothesis formation.



The following is a list of the uses that psychoanalytic diagnosis/formulation offers (McWilliams, 2011):

- 1. Psychoanalytic diagnosis is causal and multidimensional vs. simply descriptive.
- 2. It is essential for treatment planning (including the determination whether psychoanalytically informed therapy is the treatment of choice).
- 3. It generates hypotheses regarding prognosis.
- 4. It allows us to tell the patient what to expect regarding prospects, process and limitations.
- 5. The initial process of assessment is an excellent way of communicating empathy and establishing an alliance before transference-based resistances (here again, we need new language) are established. It allows the patient to tell us important things that may be difficult later.
- 6. It allows us to predict early problems and to mitigate flights from treatment.

Finally, I would suggest that psychoanalytic diagnosis/formulation is an essential part of understanding human nature, which, I hope, is a primary motive for all of us.
